ECF REGISTRATION FORM PROCEDURES

These procedures shall be used to register for an account on the Court's Electronic Filing ("ECF") system. Only those registered with the Court's ECF system will be able to electronically file documents with the Court.

You must have an upgraded, individual PACER account to file in the Western District of Oklahoma.

BY SUBMITTING YOUR REGISTRATION TO FILE IN THIS COURT, YOU CERTIFY AND AGREE TO THE FOLLOWING:

P. 49(c) shall be given to me by electronic transmission through the Court's ECF system to the E-mail Address for Service provided above. I agree that transmission to me at my E-mail Address for Service of a Notice of Electronic Service constitutes service on me of the paper or papers identified in the Notice for purposes of Fed. R. Civ. P. 5, Fed. R. Civ. P. 77(d), and Fed. R. Crim. P. 49(c).
5. If any of the information provided on this form changes, I agree to comply with the Court's local rules regarding changes of address.
